II. Purpose of Addendum

Modification request received to change and add child care space and increase overall capacity to 36.

III. Methodology

08/01/2019—Certification of school building fire safety provisions.

08/08/2019—Modification request received.

08/09/2019---Lead Hazard Risk Assessment completed. No hazards identified.

09/04/2019---Inspection completed on-site. A rating.

IV. Description of Findings and Conclusions

The child care facility is located within the Battle Creek Area Learning Center which houses an alternative education program for teens. The child care provides a Great Start to Readiness Preschool (GSRP) program for children 3 ½ to 5 years 11 months. The program operates Monday through Thursday from 8:25 AM until 3:25 PM during the school calendar year.

The following rooms are being added as approved child care space:

Room 6 measures 31.3 ft. x 29.9 ft. for total of 935.9 square footage. This room will be used as a GSRP educational classroom for all enrolled child care children. The room contains 1 hand washing sink and 1 toilet. The overall room space allows for 27 child care children.

Room 7 measures 20.7 ft. x 40.2 ft. for a total of 832.1 square footage. This room will be used as a GSRP educational classroom for all enrolled child care children. The room contains 2 hand washing sinks and 1 toilet. The overall room space allows for 24 child care children.

The following rooms are no longer approved for child care:

Room 14 was previously approved as the GSRP classroom, but will no longer be used by the program.

Though the overall room space allows for a greater capacity, the licensee has requested a capacity of 36.

There is an adequate and varied amount of developmentally appropriate equipment for the children served.

There are 3 hand washing sinks and 2 toilets immediately accessible to child care children. Additional toilets and sinks are also available in the school building.

The outdoor play area is in the side lot of the school building. A playground inspection was completed.

An updated certification of school building fire safety provisions is on file.

An A rated environmental health inspection was completed.

A lead hazard risk assessment was completed and no hazards were identified.


The child care will provide a breakfast, lunch, and one snack during child care hours. Meals are provided through the school licensed kitchen.

No transportation or swimming will occur during child care hours.

V. Recommendation

I recommend that the modification to increased capacity to 36 and add room space be approved.
