During the 03/04/2020 on-site inspection for the renewal of the license, Ms. Remington indicated that only one bedroom on the main level of the home is used for child care, yet the entire main level was listed as approved use space. She requested that just the one bedroom be approved.

## IV. Description of Findings and Conclusions

The child care is located in a single-story home in a quiet neighborhood in Okemos. The main level and basement of the home are approved for use. One bedroom on the main level is used for play yard sleeping. The main play room, eating area, back room, and a small room used for diapering are approved for use in the basement.

There is a front, side, and rear door to the home on the main level. In addition to the stairs leading to the main level of the home, there is an identified window in the basement that can be used for emergency escape.

## V. Recommendation

I approve the use of only one bedroom on the main level of the home.
