Modification request received to reduce the capacity to 36.

IV. Description of Findings and Conclusions

This license was previously modified in March 2020 and September 2019. The child care facility is located within the Battle Creek Area Learning Center which houses an alternative education program for teens. The child care provides a Great Start to Readiness Preschool (GSRP) program for children 3 ½ to 5 years 11 months. The program typically operates Monday through Thursday from 8:25 AM until 3:25 PM during the school calendar year.

The following rooms are approved child care space:

Room 3 measures 31.3 ft. x 29.9 ft. for total of 935.9 square footage. This room will be used only if necessary to isolate sick children or if needed for special activities. This room contains 1 hand washing sink and 1 toilet. The overall room space allows for 27 child care children.

Room 4 measures 20.7 ft. x 40.2 ft. for a total of 832.1 square footage. This room will be used as a GSRP educational classroom for all enrolled child care children. The room contains 2 hand washing sinks and 1 toilet. The overall room space allows for 24 child care children.

Room 7 measures 19.8 ft. x 12 ft. & 33.1 ft. x 17 ft. for a total of 800.3 square footage. This room will be used as a GSRP education classroom. The room contains 2 hand washing sinks and a toilet. The room space allows for 23 child care children.

The gym measures 35.4 ft. x 59.8 ft. for a total of 2116.9 square footage. This room will be used as a large gross motor space for all child care children. This room will not be used in determining overall capacity. The room space allows for 60 children.

Though the overall room space allows for a greater capacity, the licensee has requested the capacity be reduced to 36.

There is an adequate and varied amount of developmentally appropriate equipment for the children served.

There are 5 hand washing sinks and 3 toilets immediately accessible to child care children. Additional toilets and sinks are also available in the school building.

The outdoor play area is in the side lot of the school building. A playground inspection was completed.

An updated certification of school building fire safety provisions is on file.

An A rated environmental health inspection was completed.

A lead hazard risk assessment was completed and no hazards were identified.


The child care will provide a breakfast, lunch, and one snack during child care hours. Meals are provided through the school licensed kitchen.

No transportation or swimming will occur during child care hours.

The program directors are Sandra Miller and Jessica Sager.

V. Recommendation

I recommend that the modification to reduce overall capacity to 36.
