III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Description of Facility

Childtime Learning Center #0640 is located on W. Grand, Blvd, between Woodward Ave. and 2nd Ave., inside of the New Center Building in Detroit, MI. The center has a playground that has **not** been approved by a certified playground inspector. The Licensee is aware and has put in writing that the children will not use the playground equipment until it is in compliance with licensing rules and regulations. The children will take walks for outdoor recreation. The following rooms have been approved for child use:

- The infant room measures 545 square feet and can accommodate 10 children (ages birth to 2 ½) based on 50 square feet per child.
- The Toddler 1 room measures 567 square feet and can accommodate 11 children (ages birth to 2 ½) based on 50 square feet per child.
- The Toddler 2 room measures 437 square feet and can accommodate 8 children (ages birth to 2 ½) based on 50 square feet per child.
- The Pre-K room measures 654 square feet and can accommodate 18 children (ages 2 ½ to 5 years) based on 35 square feet per child.
- The Pre-School room measures 636 square feet and can accommodate 18 children (ages 2 ½ and 5 years) based on 35 square feet per child.
- The Multi purpose/Gross Motor room measures 223 square feet and can accommodate 6 children (ages 2 ½ and up) based on 35 square feet per child.

There are an adequate amount of toilets and hand washing sinks to accommodate the requested capacity of 60 children for a full day program.

B. Program Description

Childtime Learning Center is open M-TH from 6:30 a.m. to 6:00 p.m. They can service children birth through 12 years in age. Hot meals are provided by a licensed caterer, RTD Food Service on a daily basis. The licensee is aware that **prior** approval from the department and an environmental health inspection is required for any change in food service.

Childtime plans on using the Empowered Child Curriculum. The children are encouraged to explore and learn naturally. The rooms are arranged with centers of interest and are equipped with appropriate and varied equipment for the rooms' age groups.

The center director is Patricia VanCleave. She has earned an Associates degree in Early Childhood Education from Macomb Community College. She is currently certified in CPR and First Aid. Ms. VanCleave's credentials and background clearances are on file with the department.

C. Rule/Statutory Violations

There are no rule and/or statutory violations.

IV. RECOMMENDATION

I recommend issuance of an original provisional license to this child day care center.
