## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

### A. Description of Facility

The Banyan Montessori is located in the City of Canton at 6215 Canton Center Road, Suite 305, just north of Ford Road.

### **Approved space (room numbers, sizes, capacity and ages of children for which each room/well-defined space is approved, etc.):**

The center is using two rooms.

- Room one is approximately 1090 square feet and can accommodate 31 children at 35 square feet per child between the ages of 2 years 9 months and 6years.
- Room two is approximately 1050 square feet and can accommodate 30 children at 35 square feet per child between the age of 2 years 9 months and 6 years. This room is to be used for meals and napping. If enrollment increases in the future this room will be converted into a classroom .

The Licensee requested enrollment capacity of 20 children at this time. As the center enrollment increases she will request a modification to increase the capacity

**Equipment:**

There is adequate equipment for the amount of children that can be enrolled.

**Number of sinks and toilets:**

There are 4 toilets and 3 hand washing sinks. This supports the center's capacity.

**Outdoor play area - location, fenced or not, water hazards:**

There is an enclosed outdoor play area in the back of the building. There is no in-ground play equipment. There is a sand box and other outside toys available for the children.

**Documentation if a lead assessment was required and the results:**

A lead assessment was not needed. The building was built after 1978.

**Documentation of playground safety:**

A playground safety assessment is not needed. If the center decides to get playground equipment, they are aware that they would have to have a playground safety assessment prior to the children using the equipment.

**B. Program Description****Ages of children served:**

The Banyan Montessori will serve children between the age of 2 years 9 months to 6 years of age. Children must be potty trained prior to admission.

**Proposed days and hours of operation:**

The school will be open Monday through Friday from 7:00am to 6:00 pm.

**Full or part time (AM or PM sessions or both):**

Parents can opt for full or part time.

Hours are:

AM 8:30 – 11:15

AM 8:30 – 12:15 extended day

PM 12:00 – 3:15

PM 11:15 to 3:15 extended day

Full day 8:30-3:15

Before and after care 7:00 – 8:30 and 3:15 to 6:00

**Other program components - transportation, swimming, food service:**

Transportation is not provided.

There is no swimming component.

Children must bring a packed lunch. Snacks will be provided by the school.

**Name of program director and under what rule the program director is qualified. Document how the center meets the administrative requirement if a variance was granted.**

The program director is Sivakami Rajendran. She is qualified under R 400. 5103(3)(d) and (4).

Ms Rajendran has a Certificate from the American Montessori Society in Early Childhood with documentation that the credits earned are equivalent to 21 semester hours in early childhood education, a Bachelor's Degree in Business Administration and a Master's Degree in Human Resources and Organizational Development.
