II. Purpose of Addendum

On August 28, 2014, the program director, Ms. Julia Koumbassa, submitted a modification request to change the use of space for Classrooms #128, #129 and #132, and to change the age of Classrooms ##134, #135 and #137.

IV. Description of Findings and Conclusions

The terms of the original license have been modified on:

- August 28, 2014- Change of use of space.

The facility is located in a stand-alone building on the University of Michigan North Campus Research complex located at Plymouth Road and Huron Parkway. The facility will serve children ages birth to 12 years of age. It is set up to operate year round, Monday through Friday from 6:30 AM until 6:30 PM. Both full and part time sessions will be offered. The facility will not provide transportation. The facility will provide snacks.

On August 28, 2014, Ms. Koumbassa submitted a modification request to change the use of space: (1) Room # 128 was previously approved as the library/teacher resource room; it will now be used as an Infant Classroom for children ages 0 month through 18 months. (2) Room #132 was previously the Infant Classroom; it will now be the Art Studio for children ages 0 month through 12 years of age. (3) Room #129 was previously the Infant Classroom; it will now be the Teacher's Resource Room. Room #129 is not approved for child care use. (4) Change the age of Room #134, #135 and #137 from age 18 months to 36 months to 12 months to 36 months.

The approved space is as follows:

Room 118 –700 sq. ft. – adequate for up to 20 children, age 3 to 6 years, based on 35 sq. ft. per child.

Room 120 – 694 sq. ft. – adequate for up to 20 children, age 3 to 6 years, based on 35 sq. ft. per child.

Room 121 – 747 sq. ft. – adequate for up to 21 children, age 3 to 12 years, based on 35 sq. ft. per child.

Room 122 – 674 sq. ft. – adequate for up to 19 children, age 3 to 6 years, based on 35 sq. ft. per child.

Room 123 – 460 sq. ft. – adequate for up to 12 children, age 3 to 6 years, based on 35 sq. ft. per child.

Room 124 – 457 sq. ft. – adequate for up to 12 children, age 3 to 6 years, based on 35 sq. ft. per child.

Room 128 – (formerly known as the Library/Teacher’s Resource Room)- 400 sq. ft. - adequate for up to 8 children, age birth to 18 months, based on 50 sq. ft. per child.

Room 129 – (formerly known as the Infant Room) - 450 sq. ft. – This room is now the Teacher’s Resource Room. It is not approved for child care use.

Room 132 – (formerly known as the Infant Room) 425 sq. ft. – This room is now the Art Studio. It has adequate space for up to 8 children, age birth to 18 months, based on 50 sq. ft. per child It has adequate space for up to 12 children, age 30 months and older, based on 35 sq. ft.

Room 134 – 624 sq. ft. – adequate for up to 12 children, age 12 months to 36 months, based on 50 sq. ft. per child.

Room 135 – 468 sq. ft. – adequate for up to 9 children, age 12 months to 36 months, based on 50 sq. ft. per child.

Room 137 – 400 sq. ft. – adequate for up to 8 children, age 12 months to 36 months, based on 50 sq. ft. per child.

Room 145 – This is a large motor room approved for children of all ages. This room is open on one end and leads directly out to the outdoor play area.

Although the total capacity of the building is 153 children, the program director has requested the capacity remain at 149 children. **Therefore, the total capacity at any one time cannot exceed 149 children.**

There are 11 toilets in classrooms and two restrooms in hallways that are equipped with three additional toilets.

There are 14 hand-washing sinks in classrooms and two restrooms in hallways that are equipped with two additional hand-washing sinks.

The total of 14 toilets and 16 hand-washing sinks is adequate for the requested capacity of 149 children.

V. Recommendation

I recommend approving:

- (1) Room # 128 as an Infant Classroom for children ages 0 month through 18 months,
- (2) Room #132 as the Art Studio for children ages 0 month through 12 years of age,
- (3) Room #129 as the Teacher's Resource Room; not approved for child care use, and
- (4) Change the age of Room #134, #135 and #137 from age 18 months to 36 months to 12 months to 36 months.
