## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

### A. Description of Facility

Theresa Mitchell's child care is in a one-story, green vinyl sided house, which is located close to the intersection of M-55 and Wilber Road in Tawas City.

### Rooms and levels approved for child care use:

The main floor rooms approved for child care use includes the living room, kitchen/dining area, three bedrooms and bathroom. Quiet time or napping will occur in the three bedrooms or in the living room. There is no fire place or wood-burning stove in the home.

**Outdoor play area description:**

Outdoor play will occur in the fully fenced play area in back of the house. Children can play at the sand and water table, blow bubbles, draw pictures with sidewalk chalk, play on the Little Tykes climber equipment, use the riding toys, and other outdoor equipment. /toys. There is a pond across the street from the child care home and the fenced play area will keep the children from having access to it. Parents will be informed it is their responsibility to supervise children as they walk to and from their car and the child care home.

**Areas not approved:**

The whole house is approved for child care.

**Ages of children served:**

Children of all ages will be able to attend this child care Sunday through Saturday from 5:00 AM to 6:00 PM, with some flexibility to consider offering evening hours.

**Equipment:**

There is an adequate supply of toys and equipment for children of all ages.

**Proposed days and hours of operation:**

Days and hours of operation are Sunday through Saturday from 5:00 AM to 6:00 PM, with some flexibility to consider offering evening hours. Ms. Mitchell plans on being open every other weekend for child care.

**Previous or concurrent licenses, including children's foster care:**

Ms. Mitchell was previously licensed as a group home from 5/2012 until currently, DG350318243.

There is a front and back door that would be used as exits.
