## **IV. Description of Findings and Conclusions**

The terms of the original license have been modified on April 29, 2016.

### **A. Description of Facility**

Samantha Farver's family child care "Crafty Kid Care" is located in a one-and-a-half story white aluminum sided home with green shutters on the corner of East Washington Street and Adams Street in East Tawas.

#### **Rooms and levels approved for child care use:**

The main floor rooms to be used for child care include the living room, dining area, kitchen, bedroom (naps) and bathroom. The two bedrooms upstairs are also approved for child care use.

#### **Areas not approved:**

The second floor rooms will not be used for child care. There is no basement, only a crawlspace area under the home.

#### **Ages of children served:**

Children from birth to 12 years of age will be served.

#### **Equipment:**

There is an adequate supply of equipment and toys for children of all ages to start providing child care.

#### **Proposed days and hours of operation:**

Days and hours of operation are Monday through Friday from 6:00 am to 7:00 pm.

**Previous or concurrent licenses, including children's foster care:**

Samantha Farver has not been previously registered or licensed to provide child care or foster care.

**Exiting information (including second floor and basement):**

The front door goes to the front yard. The back door goes out to the fully fenced back yard area.

The second floor has the stairway which leads to the main level. There is also a window in the bedroom to the left identified as the fire exit that is the most remotely located from the stairwell.

**Outdoor play area description:**

Outdoor play will occur in the fully fenced back yard area. The children can play in the playhouse, on a Little Tykes slide, picnic table, sand box, crawling through large in-the-ground tires, and other outdoor play toys.

**V. Recommendation**

I recommend the addition of the second floor for child use space
