II. Purpose of Addendum

The licensee designee is requesting to change the use space by adding a second infant/toddler room to the program.

III. Methodology

IV. Description of Findings and Conclusions

The terms of the original license have been modified on 1/04/2018 and 10/16/2018.

ABC Child Care Center is located in the southern half of a single-story commercial building that also houses a dentist's office. The areas approved for childcare use is:

- The large multi-use middle room is 52 ft. x 13 ft., providing a total of 676 square feet. This can accommodate up to 19 children ages 2 ½ to 12 years.
- The infant room is 15 ft. x 11 ft., plus 7 ft. x 2 ½ ft., providing a total of 183 square feet. This can accommodate up to 4 children ages birth through 2 ½ years.
- The toddler room is 34 ft. x 12 ft., providing a total of 408 square feet. This can accommodate up to 8 children ages birth to 2 ½ years.
- The preschool room is 17 ½ ft. x 12 ½ ft., providing a total of 219 square feet. This can accommodate up to 6 children ages 2 ½ through 12 years.
- The art room is 11 ft. x 10 ft., providing a total of 110 square feet. This can accommodate up to 3 children ages 2 ½ through 12 years.
- The second infant room is 18 ft. x 11 ½ ft., providing a total of 207 square feet. This space was previously approved as the dining room area. This space can accommodate up to 4 children ages birth through 2 ½ years old. A handwashing sink was added to this room.

There is an adequate and varied amount of developmentally appropriate equipment available that offers three play spaces for the requested capacity.

Both the infant and toddler classrooms have hand washing sinks. There is a girl's bathroom with 2 toilets and 1 hand washing sink and a boy's bathroom with 2 toilets and 1 hand washing sink. There is an additional hand washing sink located outside of the bathrooms. This supports the center's capacity of 44 children.

The outdoor play area is behind the building and is fenced. There are no water hazards. There are no elevated structures.

Environmental health and fire safety inspections of all areas were completed at the time of original issuance. An updated environmental inspection was completed on February 27, 2017. An updated fire safety inspection was completed on May 22, 2015. A lead hazard risk assessment was completed on July 26, 2016. No lead risk hazards were identified, the facility was found safe for child care usage.

A lead risk hazard assessment was not required as the center was built in 1990.

The total approved space is sufficient for a total overall center capacity of 44 children ages birth through 12 years.


The program directors are Xavier Brewer, Sue Finley and Kerry Horton. Mr. Brewer qualifies as program director under licensing rule R 400.8113(9)(c) and (13). Ms. Finley qualifies as program director under licensing rule R 400.8113(9)(b) and (13). Mr. Horton qualifies as program director under licensing rule R 400.8113(9)(f) and (13).

Terms:

The facility is approved for a capacity of 44 children ages birth through 12 years of age. The center serves breakfast, lunch, dinner, and snacks to children in care.

V. Recommendation

I recommend that the second infant room be approved for use space.
