IV. Description of Findings and Conclusions

On 12/19/2017 I received a request to add transportation as a component to the license. On 01/04/2018 Ms. Mueller sent me photos of the inside and outside of the bus and the required items. I also received a photo of the annual vehicle inspection label dated December 2017 stating the vehicle has passed inspection.

On 01/10/2018 I completed an onsite inspection and observed the Gilden Woods Early Care and Preschool bus in the parking lot. The bus was equipped with a first aid kit, a 2A-10BC fire extinguisher, and appropriate flares. The bus appeared to be in good working condition.

V. Recommendation

I recommend the approval of adding transportation as a component of this center.
