II. Purpose of Addendum

A modification request was submitted to begin to utilize the tandem room attached to the infant toddler area as child use space again, as it will no longer be utilized as a staff lounge.

III. Methodology

IV. Description of Findings and Conclusions

The terms of the original license have been modified on April 27, 2017 and June 15, 2017 and July 3, 2018

On August 27, 2015, an additional preschool room was approved and measured as follows:

Preschool Rm. #2 is 18" x 14'= 252 square feet. The capacity of this room is 7.

The infant/toddler room is 30' x 23'2" = 696 square feet. The capacity of this room is 13. On April 27, 2017, the tandem room in the infant toddler area which measures 12'9" x 12'9" = 162 square feet will be utilized as a staff lounge. **On July 3, 2018 this room will be utilized as an infant toddler area again.**

On May 4, 2017, an additional preschool room was measured as follows:

Small Group Rm. Is 10' x 10' = 100 square feet. The capacity of this room is 3.

There are a total of four toilets and four sinks in the center.

The classrooms are furnished with a variety of developmentally appropriate equipment. There is an adequate amount of equipment.

V. Recommendation

I recommend approval of the additional child use space in the infant toddler area
