Dear Mr./Ms. Andree:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 02/07/2019. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

During my on-site inspection I observed breakfast, diapering, free play, and group times. Caregivers were providing appropriate care and supervision at all times. Each group was operating within required ratios. Each room was clean and included a variety of age appropriate materials for the children to access. Interactions between caregivers and children were positive and nurturing. Caregivers made sure to get down on the child's level and interacted with them during play. Programming provided was developmentally appropriate and the children seemed engaged. During activities caregivers supported learning and used encouragement.

I provided technical assistance and consultation of labeling of bottles, safe sleep requirements, emergency procedures, and new law requirements.

The violations that were found are:

R 400.8176 Sleeping equipment.

(10) Soft objects, bumper pads, stuffed toys, blankets, quilts, comforters, and other objects that could smother a child shall not be placed in a crib or porta-crib with a resting or sleeping infant.

A five-month old infant was swaddled while asleep in a crib. Technical assistance and consultation was provided to Ms. Andree and the lead caregiver. Swaddling is not allowed for infants older than two months of age. I will make a follow up inspection within three months.

R 400.8340 Food services and nutrition; provided by parents.

(3) Breast milk, formula, milk, other beverages, and food furnished in a same-day supply shall be covered and labeled with the child's first and last name and the date.

Bottles in the infant room only included the children's first name and date. I provided technical assistance and consultation to Ms. Andree and both caregivers.

R 400.8530 Hazard Areas.

(10) The center shall not store combustible materials within the central heating plant or fuel-fired water heater rooms or in basements containing fuel-fired heating equipment, without a proper fire separation.

A wooden crib and two small boxes with light bulbs were stored in the room with the furnace and water heater. Ms. Andree removed the items during my inspection.

Due to the infant safe sleep violation(s), all of your infant caregivers must take training on infant safe sleep. In addition, a follow up inspection will be made to check compliance with the infant safe sleep rules.

The Department provides technical assistance to meet the licensing requirements and consultation to improve services.
