II. Purpose of Addendum

On July 5, 2019 I received a modification request form from program director, Cyndi Andree. The request is for capacity changes in the toddler and preschool sections on the main floor, due to a reconfiguration of the spaces. The center capacity will change from 45 to 42 children ages birth to six years of age to accommodate more toddlers on the main level of the building.

IV. Description of Findings and Conclusions

The terms of this license have been modified on 10/03/200, 01/15/2002, 02/08/2018 and 07/25/2019.

This child care center is a stand-alone building on the property of Mayfair Church on the north-east side of Grand Rapids. The building has two levels.

Main level of building:

- Preschool (West side) is approximately 9 ft. X 36 ft. providing a total of 324 square feet. This accommodates nine children over the age of 30 months.
- Infant/Toddler (East side) is approximately 16 ft. X 34 ft. providing a total of 544 square feet. This accommodates 11 children over the age of 30 months.

Basement level of building:

- Infant Room (South-West corner) is approximately 20 ft. X 13 ft. providing a total of 260 square feet. This accommodates five infants. The requested capacity in this room is four infants.
- Infant Room (North-West corner) is approximately 13.5 ft. X 13 ft. providing a total of 175.5 square feet. This accommodates the requested capacity of four infants.
- The Pre-K (East side) is approximately 40 ft. X 13 ft. providing a total of 530 square feet. This accommodates the requested capacity of 14 children over the age of 30 months.

The total space is sufficient for a total center capacity of 42 children.

An "A" rated environmental health inspection was completed on 01/02/2018. An "A" rated fire inspection was completed on 02/04/2018.

The classrooms are furnished with a variety of developmentally appropriate equipment for the ages served.

There is a total of six handwashing sinks and three toilets. This supports the center's capacity.

Terms:

The center is approved for a total capacity of 45 children aged birth through six years.

The program offers a morning and afternoon snack. Parents are expected to provide lunch for the children.

The center is open year-round and offers full and part time programming.

V. Recommendation

I recommend approval of capacity changes in the toddler and preschool areas on the main level. I also recommend a center capacity of 42 children ages birth to 6 years of age.
