Dear Ms. Ervay:

This letter is a follow-up to the on-site inspection conducted at your center on 11/12/2019. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers, specifically related to child to caregiver ratios.

When I arrived at the center, I observed 3 caregivers in the preschool room with 9 children, ages 2 months to 6 years. Another caregiver was in the kitchen washing dishes. The two infants were being held by the caregivers with the remaining 7 children engaging in free play. In the infant and toddler rooms, I observed 1 caregiver supervising 11 children as some napped and others rested. The children were identified as being between the ages of 12 months and 4 years.

The violations that were found are:

**R 400.8182**      **Ratio and group size requirements**

(8) If there are children of mixed ages in the same room or well-defined space, then the ratio and group size shall be determined by the age of the youngest child, unless each group of children is clearly separated and the appropriate caregiver-to child ratios and group sizes, if applicable, for each age group are maintained.

Ms. Ervay did not ensure that the ratio of caregivers to children is maintained for the youngest child in situations where there are children of mixed ages in the same room or well-defined space. In the infant and toddler rooms, there were children under the age of 30 months, requiring there to be 3 caregivers present for 11 children.


On 11/12/2019, you gave us an acceptable written corrective action plan.
