III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Description of Facility: The home is a three-bedroom, single story, traditional frame constructed house built atop a crawl space. The home is situated on approximately three acres of land in a residential area Harrison, Michigan. The property includes a mix of forest and maintained lawn.

Rooms and levels approved for child care use: The kitchen/dining room, living room and child care room are approved for child care use.

Areas not approved: A storage/laundry room located off the kitchen/dining is not approved for child care use. Also, all three bedrooms located off a central hallway, are not approved for child care use.

Ages of children served: The child care home will serve children birth to 12 years of age.

Equipment: There is an adequate amount of play and learning equipment available for indoor and outdoor play.

Proposed days and hours of operation: Ms. Krchmar will offer child care from 8:00 AM until 5:30 PM; Monday thru Sunday.

Previous or concurrent licenses, including children's foster care: Ms. Krchmar was licensed to provide child care from 10/2017 until 11/2019 (DF180340394) at a previous location.

Exiting information (including second floor and basement): Exiting is available to grade via the front door (located in the living room on the north side of the home), the side door (located off the kitchen/dining room on the west side of the home) and two sliding glass doors (located in the child care room on the south side of the home).

Outdoor play area description: Ms. Krchmar will utilize her back yard for outdoor play. It is not fenced and there are no water hazards on the Krchmar property or adjacent properties.
