III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of applicable key indicator child care home administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff, and a review of some of the home's records, including staff and children's records.

Staff records include background checks, medical clearance information, and training information. Children's records include child information cards and child in care statements/receipts.

The facility is in compliance with all applicable rules and statutes.

During the exit conference, technical assistance was provided to Ms. Haring regarding damaged areas of the walls that were in need of patching and painting. We also discussed reviewing all child information cards to ensure they are complete, and no required sections are blank or completed with an unacceptable response such as "N/A".

IV. RECOMMENDATION

I recommend renewal of this child care child group home license (7-12 children).
