Dear Ms. McCollum:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your center on 03/10/2020. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Child Care Centers.

The violations that were found are:

R 400.8134 Hand washing.

- (3) Staff and volunteers shall ensure that children wash their hands at all of the following times:
(b) After toileting or diapering.

During the on-site inspection I observed two preschool children use the bathroom, but the children did not wash their hands after toileting.

R 400.8325 Sanitization.

- (1) All tableware, utensils, food contact surfaces, and food service equipment must be thoroughly washed, rinsed, and sanitized after each use. Multi-purpose tables must be

thoroughly washed, rinsed, and sanitized before and after they are used for meals or snacks.

During the on-site inspection I observed a toddler staff member spray the table with the multipurpose cleaner before children sat down for breakfast. The staff member did not rinse or sanitize the table as required.

On 3/10/2020, you gave us an acceptable written corrective action plan.



During the on-site inspection I provided technical assistance and consultation to staff regarding the following Child Care Center Licensing Rules:
R400.8152(3) – Medication; administrative procedures. All over the counter medication containers shall be labeled with a child’s first and last name.
R400.8176(12) – Sleeping equipment. The fitted crib sheet shall be the appropriate size such as it does not cause the mattress corners to pull up.
