## **III. Methodology**

## **IV. Description of Findings and Conclusions**

The terms of the original license have been modified on 6/21/2019, 9/24/2019 and 5/14/2020.

The rooms measure as follows:

The Busy Bees room measures 25 ft. x 9 ft. plus 15 ft. x 7 ft. for a total of 327 square feet. This is enough space for 7 children ages 1 year and older. There is 1 portable sink in this classroom.

The Wiggly Worms room measures 26 ft. x 23 ft. for a total of 598 square feet. This is enough space for 12 children ages 2 years and older and 17 children ages 2 ½ and older. There is 1 sink in this classroom.

The Dragonflies room measures 14 ft. x 12 ft. plus 23 ft. x 18 ft. for a total of 582 square feet. This is enough space for 17 children ages 2 ½ and older. There are 2 toilets and 3 sinks in this area.

The Grasshoppers room measures 9 ft. x 7 ft. plus 26 ft. x 14 ft. for a total of 427 square feet. This is enough space for 8 children ages 1 year and older. There is 1 sink in this classroom.

The Caterpillars room measures 32 ft. x 10 ft. plus 23 ft. x 10 ft. plus 8 ft. x 5 ft. for a total of 590 square feet. This is enough space for 17 children ages 3 years and older. There is 1 toilet and 2 sinks in this classroom.

The Butterflies room measures 33 ft. x 17 ft. for a total of 561 square feet. This is enough space for 16 children ages 3 years and older. There is 1 toilet and 2 sinks in this classroom.

There is an additional 2 toilets and 2 sinks in the hallway for a total of 12 sinks and 6 toilets. This is enough for the total capacity of 77.


A new kitchen has also been added to the building. There is a refrigerator and freezer, a dishwasher, a 3-compartment sink, and a hand washing sink, a stove with a hood vent, and a microwave. The center provides meals for the children.

The center's office and staff room are approved as use space. This space is approved for one child at a time who may need to be in the area with the owner, director, or other child care staff member. The child must always be supervised. This space does not count towards the center's capacity.

The new playground is completely fenced and has a bike/walking path and grassy areas. There is no elevated equipment.

**V. Recommendation**

I recommend approval of the office and staff room as child care use space.
