On 06/03/2020 during the renewal inspection, Ms. Carter requested the removal of the craft room bedroom located on the main level as child use space.

IV. Description of Findings and Conclusions

The terms of the license were modified on 06/03/2020, 05/08/2020, and 03/17/2017.

The facility is a one-story home with a basement located in rural Cheboygan.

Rooms and levels approved for child care use:

The approved child care space in the basement includes: the playroom. The approved child use space on the main floor includes: the living room, entrance/laundry room, kitchen, dining room, one guest bedroom and bathroom.

Areas not approved:

The two storage rooms and wood stove room located in the basement are neither used nor approved for child care. The master bedroom, the master bathroom, and the craft room bedroom located on the main floor are neither used nor approved for child care. The two detached garages on the property are neither used nor approved for child care.

Ages of children served: Ms. Carter accepts children ages birth to 12 years.

Equipment: There is a sufficient supply of developmentally appropriate equipment for the requested capacity of six children.

Proposed days and hours of operation: This facility operates Monday through Friday 7:30am- 5:30pm

Previous or concurrent licenses, including children's foster care: Ms. Carter has not been previously licensed for child care. Ms. Carter is not currently licensed for foster care.

There are no water hazards on the property. There are two small dogs and one cat in the home. Ms. Carter stated that all the animals have supervised contact with the children in care. There is a fireplace in the living room. Ms. Carter stated that the fireplace is not used during child care hours. There is a wood stove in the basement that is used to heat the home. There is a child proof handle on the door where the

wood stove is located in the basement. There is also a hook and eye latch on the door that is too high to be accessible to children.

V. Recommendation

I recommend the removal of the craft room bedroom located on the main level as child use space.
