III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Physical Description of Facility

This group family home was formerly licensed as a family home, and is located southeast of the city of Caro. It is a single story home, of wood frame construction. The approved use space is the playroom, 150 sq ft; the living room, 400 sq ft; a bedroom, 80 sq ft; and kitchen and dining room, 400 sq ft. The basement is not approved.

B. Program Description

The home is licensed for 12 children, ages 0-12 years, and will operate Monday through Friday 6 AM to 6 PM. The equipment available is age and developmentally appropriate, and is in sufficient quantity for the licensed capacity.

IV. RECOMMENDATION

I recommend issuance of a provisional license to this child day care group home (capacity 7-12).
