III. DESCRIPTION OF FINDINGS & CONCLUSIONS

A. Description of Facility

The day care home is a one-story house without a basement on a rural road. The home has a fenced in back yard for outdoor play. The day care provider has a good collection of age appropriate toys and equipment for indoor and outdoor use. The following rooms are approved for child use:

Living room	12 x 15
Dining room	12 x 15
Sun room	12 x 9
Kitchen	10 x 8
Bedroom 1	10 x 10
Bedroom 2	10 x 12

The day care family has one pet, a cat.

B. Program Description

Day care will be provided in a family setting Mondays through Fridays from 5:30 am until 11:00 pm. Children from birth to age 12 will be accepted for care. A flexible schedule that includes circle time, free play, stories, arts and crafts, music, movement, meals, rest times and outdoor play is planned.

The day care provider, Cathy Cook, has been registered as a family day care home at her present address. Mrs. Cook previously had a family registration and a group day care license in Bay County.

IV. RECOMMENDATION

I recommend issuance of a provisional license to this child day care group home (capacity 7-12).
