II. Purpose of Addendum

On August 10, 2005, a request for modification was received from Christian Montessori School of Ann Arbor. An addition was built onto the school consisting of two classrooms, a hallway, and three bathrooms. The request is to add one of the new classrooms to the license to accommodate a second preprimary/kindergarten program and increase the capacity of the license.

The school is offering an after school care program so the ages of children served will increase to age 14.

III. Methodology

8/10/2005	Request for modification received.
8/30/2005	Environmental Health Inspection completed.
8/30/2005	Onsite inspection completed.
9/1/2005	Office of Fire Safety Inspection. Temporary approval granted until 11/1/2005.

IV. Description of Findings and Conclusions

Christian Montessori School has constructed two new classrooms as an addition to their building. One of these classrooms will be used for a second preprimary/kindergarten program. This room measures a total of 1320 square feet. There is enough room for 30 children ages 3 years through 6 years. The license will be increased to a capacity of 66. These preschool children can attend the program Monday through Friday, 8:15a.m. to 3:30p.m. The room is arranged for Montessori education. The equipment is available and accessible to the children. The head teacher in this classroom is Carol White.

An environmental health inspection was completed on 8/30/2005 and the Office of Fire Safety inspected the new construction on 9/1/2005.

An afterschool program will operate at the school Monday through Friday from 3:30p.m. until 5:30p.m. Children up to age 14 will be serviced.

V. Recommendation

The capacity of the license will be increase to 66 and the age of children accepted will be from 3 years to 14 years.
