## III. DESCRIPTION OF FINDINGS & CONCLUSIONS

### A. Description of Facility

Vista Nuevas Eternal Rock Child Care Center is a childcare center located on Lonyo St., south of I-94 in Detroit. The approved floor level is the main floor level of the center. This program will occupy 3 classroom areas that have adequate usable floor space to accommodate the maximum capacity of 52 based on 35 square feet per child.

- Classroom #1 – 620 sq ft.
- Classroom #2 – 668 sq ft.
- Classroom #3 – 588 sq ft.
- Large Muscle Room – 518 sq ft. **(This room can only accommodate 14 children at one time)**

There are a total of 4 toilets and 4 hand washing sinks in the facility. At the time of the inspection, adequate equipment was observed for indoor and outdoor use. Currently there is no outdoor equipment on site that requires an inspection. **Prior** approval is required for any change in child use space.

**B. Program Description**

Eternal Rock will operate Monday through Friday between the hours of 8:00am and 3:30pm in half day sessions. The center will provide breakfast, lunch and a snack to the children in care. The food is prepared off site and bought to the center. The licensee is aware that **prior** approval from both BCAL and the city of Detroit health Department is required for any change in nutritional service.

The childcare center will serve children from 2 ½ years to 5 years 11months old. There is adequate and varied equipment to meet the developmental needs of children.

This program will provide early educational services to children with an emphasis on meeting their developmental needs preparing them for kindergarten.

The designated program director Carolyn Ford. Ms. Ford meets the qualifications requirements under **R400.5103 (3f) (4)**. Her credentials and licensing record clearances are on file. She has current first aid and CPR certification.

**C. Rule/Statutory Violations**

There are no rule and/or statutory violations at this time.

**IV. RECOMMENDATION**

I recommend issuance of an original provisional license to this child day care center.
